

**2) BGS Transmission Charge per KWH:** As provided in the respective tariff for Service Classifications RS, RT, RGT, GS, GST, OL, SVL, MVL and ISL. Effective January 1, 2013, a RMR surcharge of **\$0.000000** per KWH (includes Sales and Use Tax as provided in Rider SUT) will be added to the BGS Transmission Charge applicable to all KWH usage.

Effective March 1, 2016, a PATH3-TEC surcharge of **\$0.000058** per KWH (includes Sales and Use Tax as provided in Rider SUT), a VEPCO3-TEC surcharge of **\$0.000323** per KWH (includes Sales and Use Tax as provided in Rider SUT), and a PSEG2-TEC surcharge of **\$0.001998** per KWH (includes Sales and Use Tax as provided in Rider SUT) will be added to the BGS Transmission Charge applicable to all KWH usage except lighting under Service Classifications OL, SVL, MVL and ISL.
