Enclosed for filing by Atlantic City Electric Company (“ACE” or the “Company”) are three conformed copies of the Company’s compliance filing provided in accordance with the Board of Public Utilities (“Board”) Orders dated February 10, 2017 and November 24, 2014.<sup>1</sup>

At the Board’s meeting on February 10, 2017, the Board certified the final results of the BGS-RSCP (Residential Small Commercial Pricing) and BGS-CIEP (Commercial Industrial Energy Pricing) Auctions in their entirety, approved the closing prices for each Electric Distribution Company (“EDC”), and ordered each EDC to file compliance tariff sheets by March 24, 2017.

Additionally, at the Board’s meeting on November 21, 2014, the Board directed each EDC to make a compliance filing to incorporate increased capacity prices resulting from the Federal Energy Regulatory Commission approved PJM Capacity Performance proposal within 14 days of the time the new capacity prices are available to the EDCs and the Board. 
Capacity prices resulting from the Third Incremental RPM Auction for Delivery Year 2017/2018 were posted on March 10, 2017.
